This Amendment to Declaration of Condominium is made this 25<sup>th</sup> day of April 1990 by a majority of the Board of Directors and seventy-five (75%) percent of the members of the Association of Park Lake Towers Condominium Association, Inc. This amendment was approved at a duly called Special Members' meeting on March 29, 1990. Declaration of Condominium of Park Lake Towers is recorded in O.R. Book 2616, Page 1156 of the Public Records of Orange County, Florida.

The Declaration of Condominium of Park Lake Towers is amended as follows:

Article 14.2 RESOLUTION.

"An amendment may be proposed by either the Board of Directors or by ~~seventy-five-(75%)-percent~~ sixty-six (66%) percent of the members of the Association. A resolution adopting a proposed amendment must bear the approval of not less than a majority of the Board of Directors and ~~seventy-five-(75%) percent~~ sixty-six (66%) percent of the members of the Association. Directors and members not present at the meetings considering the amendment may express their approval, in writing, delivered to the Secretary before such meetings."

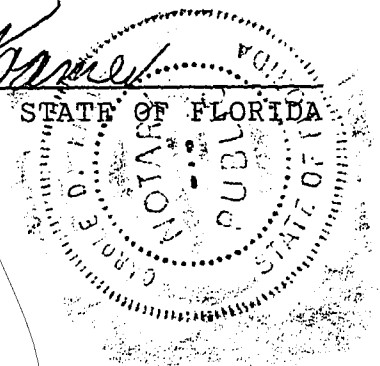
